- 2. An Individual auction will be held for the sale of bags and spices boxes. The items will be sold as a whole lot, and piece-meal purchases are not permitted. Bidders must bid for the entire lot.
- 3. Interested bidders who are unable to attend the auction can submit their sealed quotations before the auction date,(28.07.2025 by 2 PM). Such bids will be considered during the auction process.
- 4. Bids submitted in a sealed envelope must super scribe on the top;"AUCTION OF OFFICE BAG/ SPICES BOX".
- 5. Interested bidders can inspect the items two hours before the scheduled auction time, and a photograph of the items is attached for reference.
- 6. The items will be sold/auctioned to the highest bidder .
- 7. Bids below the Reserve Price fixed by this office will be rejected after due process has been followed.

- 8. The purchase price shall be quoted in figures and in words, in the enclosed schedule and in case of any discrepancy between price quoted in figures and in words, the price written in words shall prevail.
- 9. The highest bidder should pay 1/3 of the quoted price on the same day as a Security Deposit and the remaining balance within 3 days from the date of issue of bid acceptance letter. If the successful bidder fails to pay the balance amount within the stipulated time, the auction/sale will be cancelled and the entire deposit paid by the vendor will be forfeited without any notice and the items will be resold to second highest bidder.

The sold goods will be delivered to the successful bidder only after submission of documentary evidence in support of value deposited and the bidder shall arrange for shifting of sold goods from the present storage within 2 days of payment at their own cost.
